## INACTIVE INGREDIENTS:

Active dry yeast (saccharomyces cerevisae), alfalfa meal, brewers dried yeast, cobalt carbonate, corn distiller grains with solubles, dried aspergillus niger fermentation product, dried aspergillus oryzae fermentation product, dried bacillus subtilis fermentation product, fenugreek seed, fruit blend powder (apple, blueberry, blackberry, peach, apricot, raspberry, cranberry, strawberry, elderberry, bilberry & cherry), grape pomace meal, inulin, kelp, lignin sulfonate, magnesium silicate, mixed tocopherols, natural and artificial flavors, salt, sodium propionate, soybean oil and stabilized rice bran.

## CAUTIONS:

If animal's condition worsens or does not improve, stop product administration and consult your veterinarian.  
Safe use in pregnant or nursing animals or animals intended for breeding has not been proven (Devils Claw Root Extract and Boswellia Extract).

An examination from a veterinarian is recommended prior to using this product.

May be a GI irritant, use with caution in animals at risk for GI ulcerations (Devils Claw Extract and Turmeric Root Powder).

Contraindicated in animals with hypertension and anxiety, may be hypoglycemic (Siberian Ginseng).

Do not use with anticoagulants (Turmeric Root Powder and Grape Seed Extract).

Follow label directions: Feeding added selenium at levels in excess of 0.3 ppm in the total diet is prohibited.

Horses should not exceed a daily intake of 4 mg of chromium from chromium propionate.

## For use in equine only.

LAMINEX is recommended to help support healthy joint function, blood sugar levels and hoof growth.

## DIRECTIONS FOR USE:

(Enclosed measure approximates 70.9 g)

**Adult Horses (900-1,100 lbs):** Provide 1 scoop (70.9 g) **twice daily for the first 12 weeks**, reduce to 1 scoop (70.9 g) daily for maintenance.

## WARNINGS:

Not for human consumption. Keep out of the reach of children and animals. In case of accidental overdose contact a health professional immediately. This product should not be given to animals intended for human consumption.
